30.3	Construction Update:		
	 C. Kavanaugh starts the construction update. Goes over how the roof has been framed and sheathed, AVB is the air vapor barrier makes sure no leaks or water infiltration is happening. Goes over the center core area. Says they placed the slab and let it cure, now starting to place the masonry walls. Then talks about the slab on grade placement in the mechanical room, where the new electrical gear will be located. Talks about the main entrance of the building, where the waterproofing is being installed. Then says the mockup classroom is ongoing, explains how this is used to set the standard for how the rest of the work will look moving forward, DiNisco and D+W will review as well. Then goes into the corridor work that is being done. Which is the overhead ductwork that is currently being installed. Then shows another picture of the mockup and the wall that is being prepped for it. P. McGinn asks about the fan that was a noise complaint. B. Dunne says the fan is only being used during work hours. C. Kavanaugh answers saying that fan was used for dust control. Consigli had negative air machines to control the dust not going over to the school side. C. Kavanaugh says the fan is now only running during work hours from now on. R. Melville says the noise wasn't an issue. Asks to keep in mind that with the lights being on at night to be aware of the neighbors that are close to the school. P. McGinn wants the record to reflect the noise complaint was fully vetted and it was a non-issue.

	 C. Kavanaugh says the lights inside the school are on at night due to security reasons. There is lighting on the backside of the building due to the dark walkway in the morning. These lights are not pointed straight backward towards neighbors. There are tarps on the windows to reduce lighting from inside of building illuminating outside. B. Dunne asks if the mockup will be the format for all classrooms. C. Kavanaugh says for the most part yes, window placements may be a bit different, but most of the room will look the same. J. Oxsalida confirms that the exterior windows will be very similar. 		
30.4	Budget Update:		
	C. Dell Angelo goes into the budget update. Nothing has changed in the soft cost owner's contingency bucket. The only amendment that has been approved was for DiNisco #9 for additional asbestos monitoring and Geotech. There is \$195,373 remaining in soft costs. In owner's construction contingency there was change order #4 which was approved. In GMP contingency there is \$762,991 remaining and currently forecasting \$120,075.
